

Standard Bank Evolve Promotion: Terms and Conditions

Be one of the first 1664 (one thousand six hundred and sixty-four) differentiated customers to successfully spend R1000 or more using your 'Standard Bank Evolve card' (i.e. as described further below) ("**Evolve Card(s)**") on any purchase on the takealot.com website (including the Takealot desktop site and related Takealot mobi-sites and software applications, and related Android and iOS smartphone applications) ("**Takealot Platform(s)**"), AND thereby become eligible to receive a unique complimentary R300 Takealot Coupon to use on your next purchase also using an Evolve Card on Takealot Platforms (i.e. each not transferable nor refundable and may not be exchanged for cash, and otherwise as described further below) ("**Complimentary Coupon(s)**"), subject at all times to the further terms and conditions of this promotion (collectively "**Promotion**").

Important Note: This Promotion is promoted by Takealot Online (RF) (Pty) Ltd (reg. no. 2010/020248/07) ("**Takealot.com**", "**Takealot**", "**us**", "**we**" or "**our**"); and this Promotion only applies to qualifying purchases of R1000 or more on Takealot Platforms using an Evolve Card at checkout (i.e. specifically excluding payments made using Cash on Delivery, Ozow, Payflex, Mobicred and Instant EFT) ("**Qualifying Purchase(s)**"), strictly on a 'first come, first served' basis and only 1664 (one thousand six hundred and sixty-four) Complimentary Coupons available in total ("**Complimentary Coupons Limit**").

1. Promotion Period: This Promotion runs from 00h00 on 1 June 2025 until 23h59 on 30 June 2025, or until the Complimentary Coupons Limit is reached in accordance with section 3, whichever occurs first ("**Promotion Period**").

2.2. it is otherwise lawful for that Qualifying Customer to participate in this Promotion.

You will NOT qualify/you may NOT participate if you do not meet the aforesaid criteria in full nor if you are a supplier of goods or services in connection with this Promotion, nor if you are a director, member, partner, employee, agent of, or consultant to Takealot.com or Standard Bank or any other entity which directly or indirectly controls or is controlled by Takealot.com or Standard Bank, nor if you are any of the aforementioned persons' spouse, life partner, parent, child, brother, sister or business partner.

3. How to qualify/redeem:

3.2.4. Standard Bank Evolve Signature Card.

and by way of direct message to the email address used to register their Takealot account, and each corresponding Complimentary Coupon:

3.3.1. will be valid and redeemable until 23h59 on 31 July 2025 only; and

3.3.2. can be redeemed by the Successful Customer during such period on any purchase on a Takealot Platform ONLY ONCE, provided such purchase has a shopping cart value of R1000 or more (i.e. specifically excluding any purchase of vouchers, digital products or airtime) and was made using your Evolve Card at checkout.

3.4. If you did not receive the direct message as aforesaid, it means that you were not one of the Successful Customers (i.e. either because the Complimentary Coupons Limit was reached or you otherwise did not comply with any term or condition of this Promotion).
